

What is the Universal Access to Quality Tertiary Education Act or Republic Act No. 10931?

RA 10931 made it possible for students to pursue quality tertiary education without paying tuition and other school fees in state universities and colleges and CHED-recognized local universities and colleges. Students can enroll in technical-vocational education and training programs in public training institutions for free.

It provides financial aid to students from the poorest of the poor households found in the latest Listahanan 3.0 of DSWD.

Who implements RA 10931?

The Unified Student Financial Assistance System for Tertiary Education or UniFAST is an attached agency of the Commission on Higher Education mandated to implement RA 10931.

It was created in 2015 by virtue of RA 10687 as a system to unify existing government student financial assistance programs for tertiary education in the Philippines.

UniFAST ensures that deserving Filipinos are given equitable access to educational opportunities.

## TES Prioritization

UniFAST Board Resolution No. 2024-019 approves the prioritization in the following order of the allocation of new TES slots for **Academic Year 2024-2025 onwards, subject to the availability of funds:**

- Students under the most updated Listahanan for all SUCs, LUCs and Private HEIs, including PNSLs;
  - Students included in the Pantawid Pamilyang Pilipino Program (4Ps), ranked according to household per capita income for all SUCs, LUCs and Private HEIs, including PNSLs; and
  - The remaining slots are to be allocated to other poor students in Private HEIs with no SUC/LUC (PNSL) not included in the 1st and 2nd prioritization categories.
